### **TRANSPORT & PARKING**

Rosehill Gardens is situated approximately 10 minutes from the Parramatta CBD. Rosehill train station is located on the T6 Carlingford line.

For guests driving to the venue there is free parking available in stations P1 and P5, entry via Grand Avenue or P3, P4 and P5 entry off James Ruse Drive. The most convenient parking stations will be available first with the latter opening when they are full. Overflow parking is also available Infield, through Gate 2, entry via Unwin Street.

### **MOVE-IN**

## **MOVE-OUT**

Sunday 8 April, from 5.30pm & Monday 9 April, from 7am.

All exhibitors must abide by move-in and move-out schedules. This will be released in advance of the Show.

### SECURITY

The venue will have contract security services on site for the duration of the Show and to restrict access outside of the event hours. Please understand that the responsibility remains with exhibitors to secure all items, including during move-in and move-out.

### **CANCELLATION OF SHOW**

The BIA reserves the right to cancel the event should insufficient space applications be received by Friday 23rd February.

Should this occur, all applicants will be contacted and 100% of deposits paid will be refunded.

### INSURANCE

Public Liability Insurance is compulsory for all Exhibitors to the value of \$10,000,000 and a current Certificate of Currency (not a tax invoice or renewal notice) must be sent to the BIA office by 12 March 2018. The insurance must cover all days from the first day of your move-in to the final day of your move-out. Your insurance provider will be able to provide you with this document.

If you would prefer, we have retained the services of an Insurance Broker to provide Public Liability cover, arranged with QBE Insurance (Australia) Limited, for a cost of \$280 plus \$28 GST, based on a limit of indemnity of \$10,000,000 on any one occurrence. You may include this payment with your Application to Exhibit form.
