Failure to do so will result in an invoice being raised for \$308 (inc GST) and you will be included under the QBE Insurance (Australia) Limited Exhibitors PLI policy.

If you require insurance, we have retained the services of an insurance broker to provide Public Liability cover, arranged with QBE Insurance (Australia) Limited, for a cost of \$308 (inc GST), charged per show required, based on a limit of indemnity of \$10 million for any one occurrence. The insurance has effect from:
